# Proposed Email service and Productivity suite for NIFS

## 1. Background

## 1.1 Email Service

Researches of the NIFS need fast and easy access to Emails, Documents anywhere in the world with their computers or even from their smartphones. Accessing and collaborate through emails is critical when it comes to research. So it should be easy, reliable and trustworthy.

We have noted that the current email service which is locally hosted within the Institute (Open webmail) has many issues and it has missing some useful features which is critical in email communication. Namely,

- 1. Don't have a user friendly interface.
- 2. Unable to configure with Email clients such as Outlook, Thunderbird, Apple Email.
- 3. Do not provide two step authentication when login from new device/ new location.
- 4. Don't have built in spam detection. So we needs to allocate time to read that unnecessary emails.
- 5. Emails are not encrypted using industry standard encryption methods(S/MIME). So it is possible to read emails by a third party person/ programme and not recommend to email sensitive information.
- 6. Do not provide rich features like snoozing, smart replies, scheduling etc.
- 7. Unable to control confidentiality within a email service (Disable the printing, forwarding or allocate time to auto delete emails after reading).
- 8. Can't upload large attachments to emails.

Due to above issues, most of the NIFS employees are using other email platforms (Gmail, Yahoo, iCloud) for official purposes.

Therefore, the Director ask us to find a solution for the above matter and we have come up with the following solutions.

- 1. Get new domain (<u>user@nifs.ac.lk</u>) with new email server.
- 2. Apply for Google for Education Programme

If taken the first solution, we need to buy new email server, relevant software with industry standard email security features. It will also cost for maintenance including electricity and labour cost.

So, we have taken a decision to apply for Google for Education programme. Which has more benefits compared to the first choice.

## 1.2 Productivity Suite

The NIFS has used the Microsoft Office package(Student version) when purchasing new computers. The student version of the office package won't offer some important applications such as Outlook, Publisher. So, some employees purchase the professional version of the Office package depends on the requirement. This costs more than 30,000 LKR per user.

However, Mr. Gayan Bandara found that NIFS can apply for academic version of the Office Package which cost 14,000 LKR (Cost of the student version) while having all the features available in the professional version of the Office Package. However, we have noted the following issues when using the Microsoft Office package.

- Collaboration between other people, cloud storage is somewhat difficult with the Microsoft Office suite.
- Need to pay when upgrade to newer versions(Office 2013 to 2016).
- There are some incidents that employees save multiple copies of document without version control and having confuse when selecting the latest version.
- Compatibility issues when opening files in newer version and vice versa.
- Lost, Damage to files due to hardware failures.
- Unable to edit documents in real time.

Therefore, we have also considered above issues when taken the decision to apply for G Suite.

## 2. What is Google for Education ?

Google for Education, also known as G Suite for education is a programme conducted by Google to help Universities and Schools around the world to elevate higher education. They have free and paid plans for Universities and Schools depend on their requirements.

## 2.1 Application process

Currently Google only accept Universities (Degree Awarding Universities) and Schools(K-12 level) for G Suite for Education. However, since the NIFS trains postgraduate students and working number of academic staff at the NIFS, we have submitted a proposal for G Suite for Education for NIFS, requesting 500 accounts for free.

After that, we got a response from Google Cloud Support team and have exchanged few emails with Mr, Ray(Please refer annexures) from Google Cloud support (Ref #16879976). Finally we have successfully received the G Suite for Education for NIFS (Figure 1).

However, for the Institutional security, they request us a confirmation from Director/ NIFS that the new domain will only use for the favor of the institute and not in favor of group, organization, class or teacher related to institute or outside of the NIFS. Therefore, we need to make sure that NIFS is continually comply with that in the future. Otherwise we will lose the G Suite for Education.

## 2.2 What's included in G Suite for Education

We have received 500 free user accounts with unlimited space for the domain nifs.ac.lk and we can extend it in the future through a separate request. The below features can be use for the NIFS.

### 2.2.1 Google Email

We can use google email platform as our email platform. Which means we can use the same email features provided by Google with our own domain (nifs.ac.lk). Google's mail platform facilitates confidencial email communication. Which means the emails send using this method can't forward, print or edit by receiver and we can also set a expiry date. So no one can read such documents after that period.

The email signature can be created using the same template for the organization and we can also add promotional banner for selected emails/ users. As an example, if we have open the registration for International Conference, we can put a banner on each email which will communicate through our domain. This can be configure by the admin.

We can also use emails to replace memos. At the end, we have all the emails in one place. The approval process and commenting can be done using replies.

#### 2.2.2 Google Calendar

We can use Google Calendar for schedule meetings, Book Auditoriums and conference Facilities. All the appointments can synchronize across all the users/ devices.

### 2.2.3 Google Drive

Each user has unlimited storage for Google Drive, Gmail, Google Docs, Google Sheets, Google Slides and Google Photos. Which means we can reduce the cost we paid for large Hard Disk Drives in the organization. This storage can also use for backup our data.

#### 2.2.4 Google Productivity Suite

Google Productivity suite includes, Google Docs, Google Sheets, Google Slides and Google Keep which is an alternatives for Microsoft Office Word, Excel and Powerpoint.

NIFS paid lot of money for Microsoft Office Package (14,000 LKR per user). Its true that Google Productivity suite does not have all the features coming with Microsoft. But it'll continually update and add new features frequently. However, it has all the common features which we use day by day.

The files created, edited using Google Productivity suite can be edit, view on Microsoft office packages and vice versa. Some useful features are,

- Collaboratively edit documents while having a version control.
- Offline access.
- Can use voice typing (Sinhala and English) to reduce the time for typing.
- Translate documents to other languages (Including Sinhala). However, there are some grammar issues when translate Sinhala to English.
- Easy to type Sinhala without using Unicode keyboard format.
- Easy to analyze and create charts using Machine Learning (We can type some questions in English and Google will show the solution by analyzing data in the document).
- Convert PDF files to editable documents(word files) including Sinhala.

## 2.2.5 Google Keep

We can use Google keep for replace the use of sticky notes. The notes will available on all the devices and can share with others. It can also use for capture text from images (Scan a business card and use that details to create a new contact).

We can also use this to take down meeting minutes and share with other committee members for approval.

### 2.2.6 Google Hangout

Google hangout is a alternative for Skype. We can use video conferencing facility to deliver a presentations, conduct a meeting, recruit candidates which live in geographically distant location. We can also record such lectures and share it on Youtube.

## 2.2.7 Google Forms

Google forms can be used for conduct surveys, get feedback from participants. The data will be available in realtime on Google Spreadsheet. It also provides quick analysis of the data.

### 2.2.8 Admin Panel

The most important feature in the G Suite package is the admin panel. We can configure, manage and control each and every feature in the Google and it is really easy to do so. Currently this is admin by Mr. Viraj Ekanayake and needs to hand over to relevant authority.

### 2.2.9 Google Sites

We can create personal pages or any simple websites with Google sites. Since we have unlimited capacity we can expand it in the future. Building a website is really easy with available templates.

### 2.2.10 Other Features.

We have only mentioned the main features which is more relevant to NIFS. We can use other Google Features which is available for G Suite for Education. This can be added by the admin in later.

## 2.3. Privacy and Security

Google has robust global infrastructure, along with dedicated security professionals and offer a highly secure, reliable, and compliant environment.

Each email, attachment, document uploaded or sent using G Suite for Education will be encrypted. Which means, it only decrypted by the receiver/ owner of such document. The emails, documents uploaded/ send by users cannot accessed by the domain admin or other google employee. In the privacy statement, Google emphasize that they won't use any data from Google for Education to target advertisements or share information with third party.

However, there are some incidents that some data of Google users has been taken by third party developers, hackers. Such incidents can't avoid in this digital era. But we should continually monitor and take risk assessments to prevent such issues from our end. Also we suggest users to not to upload sensitive information to Google Drive.

If we want to migrate from G Suite, we can download all the data which is uploaded and available at Google any time.

## 2.4 Cost

The G Suite for Education is absolutely free for NIFS and they have no plan to make it a paid service at the moment. This is a great offer for NIFS. If we purchase it from Google, it'll cost us approximately 10,200,000 LKR per year.

G Suite Value = ((\$10 per user\* 500 accounts) \* 12 months) + TAX = **\$60,000** 

Price in LKR = 60,000 \* 170 (Current \$ rate) = **10,200,000 LKR** 

So we need to take the advantage from this and implement the G Suite ASAP.

## 3. Configuration

The following configuration needs to do immediately in order to use all the services offered by G Suite. The first two needs to complete by the Computer Unit of the NIFS.

### 3.1 Add CNAME record to server

Currently the domain nifs.ac.lk is verified through the NIFS website and it needs to add the following records to the server. This is an essential part because this will tell Google that we own the domain nifs.ac.lk. For the application process, we have add this using our website and need to it in the following way for a better reliability. Please refer

3.2 Add MX records to server

We needs to add MX records to server in order to receive email to the nifs.ac.lk domain. Please refer <u>https://support.google.com/a/answer/140034</u> for instructions.

3.3 Add new admin

Currently the domain nifs.ac.lk is adminitrated by Mr. Viraj Ekanayake and this needs to handover to authorized person for future works. We are willing to provide our continual support when necessary.

## 4. Implementation

4.1 Develop an email and IT policy to NIFS

NIFS needs an email and IT policy in order to make this a successful implementation. This should include

- Using Institutional emails
- Using Cloud Storage
- Using Internet and other IT facilities at NIFS
- Actions taken for misuse of such services and facilities.

The policy maker can use SEDU's IT policy and procedure as a base template which was implemented and using more than a year.

4.2 Naming convention for email addresses.

The new email addresses can be used by

- Scientists
- Research Assistants
- Technical Staff

- Dissemination and Information Staff
- Administrative Staff
- Accounts and Procurement Staff

#### 4.3 Current Email Service

We suggest to keep the existing email accounts and the email server till the G Suite is fully functional in the institute and all the existing users who use ifs.ac.lk domain has completely migrate to the G Suite.

## 5. The Role of the Domain Administrator

The most important role of the G Suite is domain admin. The domain admin is responsible for

- Create, modify email policy of the organization.
- Add, remove users to G Suite.
- Being the first contact person for Google Team.
- Communicate with Google Team and negotiate with them get new features to NIFS at lowest cost.
- Monitor and take necessary action to prevent loss of data, Improve the security and ensure the privacy of the users.
- Train new users.
- Find, learn new features and implement relevant features at NIFS.
- Configure and optimize G Suite through Admin console.
- Network with other G Suite admins in the world to get updated about relevant practical issues and take necessary actions to overcome such issues.
- Continually update with Google's term and conditions, privacy policy and make necessary actions to comply with Google.

Also the admin should be able to implement the above suggestions successfully at NIFS and continually take necessary actions to improve the productivity of the NIFS while effectively manage the negative attitudes of the employees. The new admin can follow <u>this link</u> to view the G Suite administration training which is available for free.

Currently the G Suite is administered by Mr Viraj Ekanayake and it needs to transfer to someone else since he needs to complete the new NIFS website within next 06 months.

## 6. Government support for Implementing G Suite

The Ministry of Science, Technology, Research, Skills Development and Vocational Training and Kandyan Heritage has organized a workshop on "Using Google to improve the productivity" on 18/10/2018 at Nenapiyasa Auditorium, Colombo. They have invited the Head of the Institutions and another person to attend the workshop which represent Universities, Research Institutes in Sri Lanka.

As nominated by the Director/NIFS, Mr Viraj Ekanayake has participated to the workshop behalf of the Director and the NIFS.

As a summery, Mr. Clehan Pulle from Finetech Consultancy (Pvt) Ltd (one of Google for Education Partner in Sri Lanka) has introduce and done a live demonstration on G Suite for Education. Some of relevant features to NIFS has mentioned in previous sections in this document.

In his presentation he mentioned that G Suite for Education accounts only available for free for students. Lectures and other staff should be paid for the G Suite (\$50 per person per year using lowest plan which only available 30GB storage). However, Mrs. Wasantha Perera (Secretary of the MOSTR) has told that the ministry will be paid the cost for Lectures and staff.

After end of the workshop, Mr. Viraj has met Mr. Pandula from Ministry's IT Division and he told that they haven't finalize the G Suite purchasing process and they are trying to negotiate with Google to get reduced price. The decision will be informed us in the future.

Since, we have already received 500 unlimited G Suite accounts for free, we can continue our implementation without waiting for Ministry's response.

I have cc'ed the management of the institution, and I would kindly ask you to confirm that the new domain name will be used in favor of the institution and not in favor of a group, organization, class or a teacher related to the institution or outside of it. It is required the response comes from the School Director: Prof. Saman Seneweera (dirifs@yahoo.com). I appreciate your cooperation.

Since, they acknowledge us to only use the G Suite in favor of the institute and we use the G Suite only for the favour of the institution (as a whole) we believe that we don't have to pay for accounts used by Scientists and other staff. In our proposal, we have also mention that this service will be used by/ benefited by Scientists/ Researchers, Students and non-academic staff and they haven't mentioned about we need to pay for that (Annexure 3).

## 7. Conclusion

We hope that the NIFS will be benefited from using G Suite for Education. This would be a good move to NIFS to reduce the maintenance cost and improving the productivity while achieving a paperless environment.

NIFS researches need to get meeting appointment by physically meeting the person. And also needs to follow up whether the meeting was scheduled correctly or not. This can be overcome with Google Calendar. Which reduces that time-consuming task. Within a few minutes, we will be able to arrange, schedule a meeting and get feedback instantly.

Writing thesis, Research papers, make presentations while collaborates with Scientists and students is really difficult now. So the Google Docs will be an easy solution for this. And we don't need to worry about the physical media failures because it is hosted on the cloud and also we can take a copy in our local computers. So we can collaborate with research teams easily by just focus on the research.
